GREETINGS FROM THE EXECUTIVE DIRECTOR



In this year that marks The Council's 60th anniversary, I find myself pausing to reflect upon our history and the impact Council activities have had on the Greater Bridgeport community. I have personally had the good fortune of being part of that history for the past 27 years, and I know first hand that connections count – indeed, making connections is what The Council is all about – our mission statement embodies the very concept. Thanks to the connections we've forged with congregations, foundations, community organizations and caring individuals, opportunities for life changing and community strengthening have become a reality for thousands of people.

Over the past 30 years we have assisted more than 10,000 youth struggling with personal, social, school, and family problems. This year Janus House Center for Youth in Crisis staff responded to approximately 400 referrals, and offered intervention and support services to all. We provided a short respite stay for 51 of these young boys and girls at one of our two on-site host homes: 49 were reunited with their families following successful conflict resolution.

Project Learn Centers have helped approximately 5,000 Bridgeport school children with homework and provided recreational activities in safe and nurturing environments since 1969. We tracked report cards over the last two years and documented significant improvement in academic performance and school behavior by participants. During the past school year 184 children were registered Project Learn students. This year, through a collaborative community grant, Project Learn expanded to work with church based pre-school programs to assess their needs and assist them in obtaining training and resources.

CO-OP Center has served nearly 20,000 individuals involved with the correctional system over the years, helping them to create second chances to become productive members of the community. During the past year, 685 clients received services from our staff and volunteers from local communities, congregations and organizations. In addition, we provided interested clients with 750 hours of computer training, further enhancing their employment options.

Hunger Outreach has worked with local congregations and community organizations to feed children, families and individuals living in poverty. During our Food Bank days, we generated as much as a million pounds of food a year for Greater Bridgeport feeding programs. This year, we expanded from 28 to 31 food pantries and soup kitchens, and now collectively feed about 1,000 individuals per day, providing the equivalent of 900,000 meals per year.

We constantly strive to engage community leaders and clergy in dialogues on issues vital to the quality of life in the region, such as hate crimes, immigration, race relations and property taxes. We convened ecumenical and inter-religious occasions for education, prayer and reflection. Our annual Bridge Building Conference for Youth and Young Adults offers area high school and college students an opportunity to learn how to effectively and faithfully live and work in today's diverse world, respecting and embracing ethnic, religious and cultural differences.

Broken lives can become whole through connections with genuinely caring people. Connections count! And we are thankful for our connection with YOU!

GREETINGS FROM THE PRESIDENT, BOARD OF DIRECTORS

Amidst all of this activity, we find ourselves in a time of major transition and change. After 23 years as the leader of The Council, Rev. John Kidd has accepted a unique challenge with a call to service in Moscow. He leaves The Council in a strong position to continue the good works he has orchestrated for the past two decades.



Looking to the future we are committed to continue and strengthen our service efforts. The adopted budget for the new fiscal year calls for a 10% increase in spending, which translates to healthy growth. Project Learn is on track to open an additional site this fall. A recently established matching gift insures funding for this new site for at least two more years. Janus House Center is committed to serving more children in need. This fall, we will kick off a three-year initiative to increase awareness and funding for program. We are also seeking funding opportunities to expand Juvenile Justice diversion activities, and recruit and train community Host Homes.

Experts predict an increase in the number of clients released from the judicial system and in need of services provided by CO-OP. This includes immediate re-entry services, as well as long term education and job development opportunities. Hunger Outreach has applied for a federal grant that would help launch a sustainable urban farming project in collaboration with new partners, Connecticut Audubon Society and the University of Connecticut Agricultural Department. Low income people of the region would benefit from a new source of nutritious fresh produce and a unique opportunity to learn how to grow their own food.

A priority for the future is to reconnect and strengthen existing connections with our member congregations. We have been blessed with generous financial support, expert counsel, and consistent volunteer efforts from dozens of members of our Council family. Our desire is to breathe new life into our Council Delegate structure. Information regarding planned activities to accomplish this goal will be coming out in the near future.

The leadership team – Board and staff – is excited about the opportunities this period of transition and change may present. We are confident that – acting together – we will achieve positive results, move The Council forward, and enhance our efforts to work on behalf of people in need in the Greater Bridgeport area.

This “Sixty Years of Great Friends” Annual Report gives testimony to the hundreds of caring individuals and organizations who have invested in our work and mission.

We are doubly blessed by your gifts, for they, in turn, bless the lives of others.

PROJECT LEARN

Challenging Children to Learn

Project Learn provides after-school homework help, healthy snacks, recreation and enrichment activities for Bridgeport school children, ages 5-12. Focusing on small groups of learners, Project Learn reaches children through neighborhood-based centers located in public housing developments and in neighborhood congregations. Project Learn challenged 184 children to learn over the past school year.

JANUS HOUSE CENTER FOR YOUTH IN CRISIS

Caring for Youth in Crisis

Janus House assists youth facing serious problems with their families, schools or the juvenile court. Our mobile intervention team supports the program's Safe Place network, responds to the 24-hour Youth In Crisis Hotline, and provides counseling and referrals to necessary services. If a youth cannot return home and is not under state care, Janus House Center provides short-term respite care. This past year we responded to 400 referrals and provided 51 youth with host home care.



CO-OP CENTER

Creating Second Chances for Adults

CO-OP helps men and women released by the court or jail to reorient their lives and become contributing members of the community. The program offers pre-trial alternatives to incarceration, pre-release counseling and, upon release, individualized re-entry programs designed to meet critical needs such as secure employment, legal ID, a high school diploma and housing. During the past year, 685 clients were served. In addition we provided over 750 hours of computer training to interested clients through CO-OP's Technology Learning Center. (TLC ♥)



FAITH AND COMMUNITY

Connecting Diverse People and Communities

The Council encourages congregations to act together on community concerns through the following activities:

BRIDGE BUILDING advances inter-group relations through an annual conference that engages urban and suburban youth and young adults from Christian, Jewish, Muslim, Hindu and Buddhist backgrounds in dialogue that builds understanding and respect over racial, ethnic, and religious differences. Bridge Building also annually hosts three or four leadership breakfasts to foster inter-group understanding and collaboration among community leaders dealing with important issues.

HUNGER OUTREACH promotes hunger awareness and administers FEMA grant and private donations to support 31 Hunger Outreach programs that feed about 1,000 individuals per day and serve 900,000 meals per year.

FAITHFUL VOICES relates to controversial issues of importance to the community, surveys the views of religious leaders, conducts focus group discussions and reports an overview of these voices to congregations and local media.

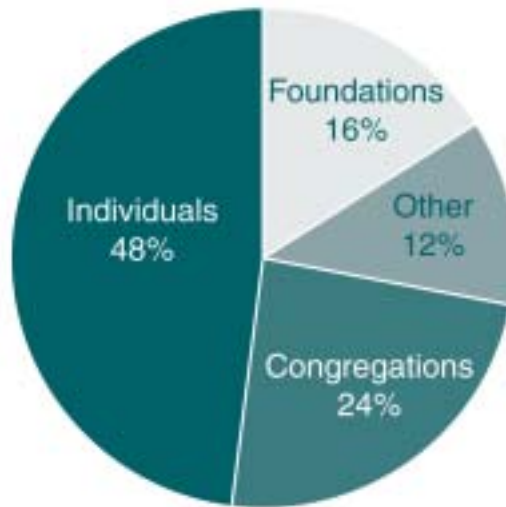
